
Subject:- Fixation of Water Usage Charges.

Water Usage Charges for Extraction and Usage of Ground Water


S.No.	Category of Use	Usage Charges
1	Filling of Water tankers for drinking or any other such use	Rs. 10.00 per kl
2	Industrial use (e.g. Cold drinks, Breweries, Mineral water, ice factory or any other such use	Rs. 50.00 per kl
3	Brick Kiln for purpose of making bricks, Tiles, or any other such use	Rs. 30 per 1000 bricks or tiles or any other such item
4	Crushers where sprinkle of water used	Rs. 5 per hundreded CFT of Curshed material
