Subject: - Fixation of water usage charges for generation of electricity.

Order No.39 / JKSWRRA of 2019.
Dated: 02 - 04 - 2019.

Whereas, in exercise of powers conferred under section 128(2) and section 145(2) of Jammu and Kashmir Water Resources (Regulation & Management) Act, 2010, the State Water Resources Regulatory Authority issued Order No. 21/JKSWRRA of 2017 dated 28.12.2017, wherein among other uses, the tariff for water usage charges for generation of electricity, as already notified, was continued to remain valid till 30.06.2018;

Whereas, the Authority vide Order No. 47/JKSWRRA of 2018 dated 28.06.2018 again extended the validity of the tariff for generation of electricity up to 31.03.2019; and

Whereas, the Authority in the meeting held on 27.03.2019, after having given a careful consideration, was of the view that presently there was no need of revising the water usage charges for generation of electricity, nor any petition on any aspect of these charges stands received from any quarters;

Now, therefore, in terms of section 128 (2) and section 145 (2) of the Jammu and Kashmir Water Resources (Regulation & Management) Act, 2010, it is ordered that the validity of existing water usage charges for generation of

electricity is extended for a further period of 1 year i.e. up to 31.03.2020. The existing water usage charges, for recapitulation, are as under:

S. No.	Head	Tariff
1	For Hydro electric plants with head up to 30 m	Rs. 0.05/m ³
2	For Hydro electric plants with head from 31 m to 60 m	Rs. 0.12/m ³
3	For Hydro electric plants with head from 61 m to 90 m	Rs. 0.15/m ³
4	For Hydro electric plants with head above 90 m	Rs. 0.25/m ³
